3. Have some exciting plans for ABCD & things planned for all of the reps, so look forward to that!

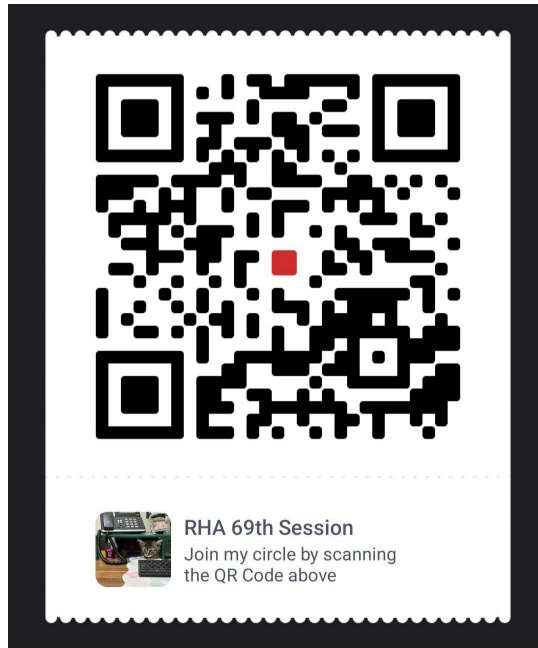
D. Vice President of Internal Relations – Jaidyn

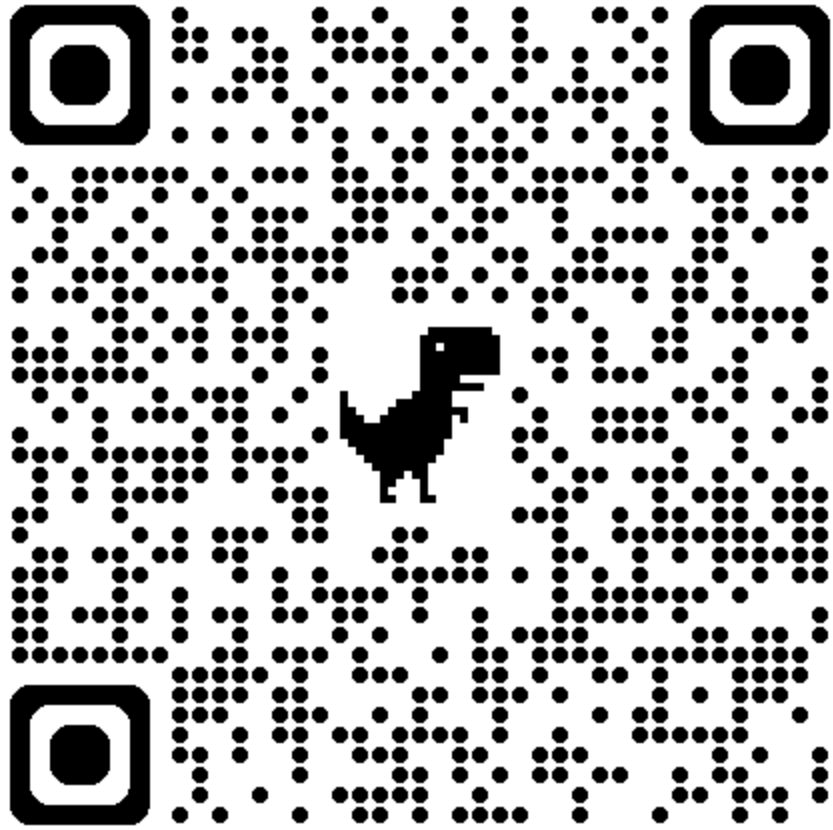
